

## **Qualified Autism Services Practitioner (QASP) Certificate Program**

## **Syllabus**

**Course Description:** Participants will learn about and understand Autism Spectrum Disorders and applied behavior analysis and will earn a certificate of completion for the Qualified Autism Service Practitioner (QASP) program. This course is for those professionals and paraprofessionals who currently provide or want to provide behavioral health treatment and professional services. The program covers applied behavior analysis and other evidence-based behavior intervention programs which develop or restore, to the maximum extent practicable, the functioning of an individual with pervasive developmental disorder or autism. Participants will learn to develop and implement treatment plans that utilize evidence-based practices that have demonstrated clinical efficacy in treating pervasive developmental disorder or autism.

The QASP Certificate Program is pre-approved by the QABA Board for meeting the 188 QASP training hour requirements. This certificate program includes the required supervision training to earn the QASP-S endorsement upon successful completion of the QASP examination.

Twelve professional development credits are available from the University of Massachusetts Global for this course.

Training Hours: This course is the equivalent of 188 contact hours.

**Class Policies:** Students are required to participate in the online courses and complete all activities and quizzes based on a 90% or higher performance criterion. A course certificate of completion will be given contingent upon 90% average mastery of exams, completion of all course lessons, and full payment of all tuition and/or fees.

**General issues about this course:** Classes will be conducted in an online forum and will be self-paced by the student.

**METHOD OF EVALUATING STUDENT PERFORMANCE:** This program is completely online, self-paced, on demand, and tablet friendly. Participants must pass the quizzes and knowledge checks at a 90% pass criteria in order to move to the next lesson and topic area. A participant may retake the quizzes as many times as needed until the 90% pass criteria is met. This Certificate Program includes 28 hours of ethics and ethical issues related to providing ABA treatment to individuals diagnosed with autism and related disorders.

#### A typical lesson requires a candidate to:

Study materials, complete readings etc-->Demonstrate conceptual understanding and recall of core content --> Review material where weaknesses or misunderstandings are identified --> Re-demonstrate conceptual understanding and recall of core information --> Final review of lesson materials --> Pass final lesson assessment at a greater than 90% level of accuracy.

Candidates are tested/assessed continually throughout the study process. Concepts and defined competencies are tested upward of three times prior to being able to complete the program.

Students must participate in all lessons for each class and attain 90% or higher average on probes (Quizzes), online activities, and exams. "Probes" are based upon content of the prior few classes and are not inclusive of material in other areas.

**Final Quiz.** After completion of the lessons and passing of the probe quizzes at 90% or higher, the student will then be asked to take a final quiz. The final quiz is comprised of questions from the probe quizzes already encountered throughout the course. The learner is expected to pass the final quiz at 90% or higher. The learner has unlimited attempts to pass at the 90% mastery level.

**Follow Up.** Once all the steps have been passed in the course, a short survey will unlock. After completing the survey, the learner can then unlock the certificate of completion for the course. The learner can print it out or save a digital copy for his/her records. Once completed, learners can apply to the University of Massachusetts Global for 12 professional development credits for an extra fee.

**TEXTBOOKS AND/OR OTHER STUDENT MATERIALS** The course is offered online with all necessary reading materials self-contained in the course. All topic assignments are integrated within course completion requirements online. All work is sequential so that concepts, competencies and objectives build upon each other as per Bloom's taxonomy which forms the basis of how a program's educational objectives are developed.
